

## INFORMATION ON THE PROCESSING OF PERSONAL DATA PURSUANT TO GDPR 2016/679

This Privacy Notice – provided pursuant to Article 13 of EU Regulation 679/2016, concerning the protection of personal data of natural persons (hereinafter referred to as the "GDPR") – aims to describe how the website manages the processing of personal data of those who interact with the web services accessible electronically at the following address: <https://stampotecnica.com/>.

The Data Controller is responsible for ensuring the lawful and fair use of your personal data and can be contacted for any information or requests regarding this processing.

### Types of Data Processed

1. Data necessary for the operation of the site: The IT systems and software used for the operation of this website collect some personal data, the transmission of which is implicit in the use of internet communication protocols (e.g., IP addresses or domain names of the computers used by users connecting to the site, URI addresses of the requested resources, request time, method used to submit the request to the server, file size obtained in response, and other parameters related to the user's operating system and computer environment).
2. Data voluntarily provided by users: The optional, explicit, and voluntary submission of your personal data (personal details and contact information) to the address indicated on this site, or by filling out the form to request a quote or further information about our activities, results in the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data provided in the message.
3. Newsletter: When subscribing to the newsletter, the website will collect your personal identifiers (name, surname, email address, phone number) and your preferences regarding the newsletters you wish to receive.
4. Work with Us: In the "Work with Us" section of the website, you can apply for any open positions. To participate in the selection process, you must provide your personal details (name, email address, physical address, phone number) and professional information (CV, cover letter, work experience, and education).
5. Cookies: Cookies are also used, which are packets of information sent by the website server to the user's browser and automatically stored on the user's device (PC, tablet, smartphone, etc.), and then sent back to the server with each subsequent access to the site. For information on the types of cookies used, please consult our Cookie Policy.

### Provision of Data

For processing related to the newsletter and the use of cookies (except for technical cookies), consent is required, and the provision of consent is always voluntary.

For all other processing, the provision of data is necessary to respond to requests received and to any

subsequent contractual or pre-contractual activities.

### **Purpose and Legal Basis of the Processing**

1. Data necessary for the operation of the site: These data are used solely for obtaining statistical information, not associated with any identifiable user data regarding site usage, and to check the correct functioning of the site. They are deleted immediately after processing. Although these are not collected for the purpose of identifying specific users, they may, through processing and association with third-party data, allow identification. The data could be used to determine responsibility in the case of potential cybercrimes against the site.
2. Data voluntarily provided by users: Personal data sent through forms will be collected and processed solely to follow up on the request for information, contacting the user using the provided contact details. The legal basis for this processing is the execution of pre-contractual measures requested by the data subject (Article 6, letter b of the GDPR).
3. Newsletter: Personal data may be processed for sending direct marketing communications, newsletters, advertising materials, and conducting market research, through traditional contact systems and automated computer systems, including email communications. The legal basis for this processing is the consent of the data subject, expressed through the “flag” option during the newsletter subscription process. Please note that the right to object to data processing for marketing purposes remains valid, where the user can object to the use of automated or digital communication tools, or alternatively, to traditional communication tools.
4. Work with Us: These data will be processed solely to proceed with the selection process and to contact the candidate, arrange interviews, and evaluate their application. All data will be deleted after two years from submission. The legal basis for this processing is the execution of pre-contractual measures (Article 6, letter b of the GDPR).
5. Cookies: Except for strictly necessary cookies, which will only be used for the proper functioning of the site, other cookies may be used for analytics and promotional purposes. The legal basis for this processing is consent, which the data subject may express separately for each type of cookie by interacting with the cookie banner when accessing the website for the first time.

### **Place of Processing, Recipients, and Data Transfer**

The processing related to the web services on this site takes place at the above-mentioned address and is carried out solely by authorized personnel (employees, collaborators, data processors) or external consultants who act as data processors for ongoing or occasional maintenance (e.g., software developers, website administrators).

No data derived from the web service is shared or disclosed. Personal data provided by users requesting information are used solely to provide the requested service and are shared with third parties only when necessary for that purpose.

Such third parties may include:

- External providers
- Companies performing regular or extraordinary maintenance of the website
- Third-party service providers

Your personal data will not be transferred to any non-EU country or international organization.

**Processing Methods and Retention**

Personal data are processed using automated tools for the time strictly necessary to achieve the purposes for which they were collected, unless the information is subject to further processing by the Data Controller. Specific security measures are observed to prevent data loss, unlawful or incorrect use, in accordance with the obligations for compliance with minimum security standards.

In any case, upon withdrawal of consent, the data will no longer be processed unless they are necessary for the management of potential disputes.
